## Call to order/Roll Call/Determination of Quorum

## Reports of Officers:

<u>**President's Report**</u> – Diane discussed a letter received from an attorney representing an owner who's vehicle was towed.

<u>**Treasurer's Report**</u> – Ron reported that the association finances are in good shape and he is working on the 2018 budget. Vicki was advised there is only \$1,300.00 left in the mulch budget for 2017.

**Compliance Committee** – The wooden planter has been removed. Second notices on past due unit owners have been sent out. Letters requesting keys have been sent out. Second phase of letters for water heaters have been sent out.

## Manager and Maintenance Reports

**Manager Report** – Management ask the board to consider vacuuming out the a/c drain lines by an a/c company. Management will get bids for the board to review. Stan presented 2 bids to the board, one for concrete work at a cost of \$3,888.00 by Alan Spears and a bid for \$720.00 by Markham's to trim palm trees. Stan also advised the board that the new fence has been installed and painted.

**Maintenance Report**– Stan presented a bid to the board for \$9,900.00 to remove the muck from water feature in an attempt to locate a possible chimney. He also presented the board with a bid to install clay in the bottom of the water feature at a cost of \$19,900.00.

<u>New Business</u>- Mrs. Mermer has requested installation of a Ring Central door bell and requested that the oak tree behind her unit 179 be limbed so she can see the golf course. Her requests have been tabled at this time.
