## AMENDMENT OF KESTREL POINT <u>DECLARATION OF SUPPLEMENTAL COVENANTS, CONDITIONS AND RESTRICTIONS</u>

THIS AMENDMENT TO THE KESTREL POINT DECLARATION OF SUPPLEMENTAL COVENANTS, CONDITIONS AND RESTRICTIONS, made this 30 day of October, 1996, by HAILE PLANTATION CORPORATION, a Florida corporation, whose post office address is 5300 S.W. 91st Terrace, Gainesville, Florida 32608, hereinafter referred to as "the **Declarant**",

## WITNESSETH:

WHEREAS, Declarant made and entered into the Kestrel Point Declaration of Supplemental Covenants, Conditions and Restrictions, (the "**Declaration**") said Declaration being recorded on December 20, 1995 in Official Records Book 2042, page 2086 et. seq. of the Public Records of Alachua County, Florida, and amended at Official Records Book 2073, page 1410 of the Public Records of Alachua County, Florida;

WHEREAS, Declarant wishes to amend the Declaration to allow for the reduction of minimum living area square footage in Unit 18, Phase III; and

WHEREAS, Declarant has the right to amend the Declaration pursuant to Article XI of the Declaration.

NOW THEREFORE, the Declaration is hereby amended by Declarant to read as follows:

ARTICLE X, <u>RESTRICTIONS</u>, <u>Section 1</u>. The living area of any residential unit within a particular phase shall not be less than as provided below:

Unit 18, Phase II: 2500 square feet Unit 18, Phase III: 1800 square feet Unit 18, Phase III: 3500 square feet

Living area shall be defined as space that is heated and air conditioned.
